The Academy Committee may have up to 10 members but no less than 7 and will consist of:

- Academy Headteacher;
- Two elected Parent Members elected by the parents or carers of registered students at the Academy;
- Two Staff Members, but not less than one, elected by the staff of the Academy;
- Three to five Trust Appointed Members.

Appointment of Members

Parent Members shall be elected by parents of registered students at the Academy. A Parent member must be a parent of a student at the Academy at the time when he/she is elected. The Academy Committee shall make all necessary arrangements for, and determine all other matters relating to, an

election of Parent Members, including any question of whether a person is a parent of a registered student at the Academy. The arrangements made for the election of a Parent Member shall provide for every person who is entitled to vote in the election to have an opportunity to do so by post or, if he/she prefers, by having their ballot paper returned to the Academy Trust by a registered student at the Academy. Where a vacancy for a Parent Member is required to be filled by election, the Academy Committee shall take such steps as are reasonably practical to secure that every person who is known to them to be a parent of a registered student at the Academy is informed of the vacancy and that it is required to be filled by election, informed that he is entitled to stand as a candidate, and vote at the election, and given an opportunity to do so.

Staff Members shall be elected by staff members at the Academy. A Staff Member must be a staff member at the time when he/she is elected. If a Staff Member ceases to be a staff member then they shall be deemed to have resigned and shall cease to be a Member of the Committee.
